TEXT: Sentencing as to Hanan Ofer (2) held before Judge Diane Gujarati on August 30, 2023. AUSA Francisco J. Navarro appeared on behalf of the Government. Retained counsel Arthur D. Middlemiss appeared on behalf of Defendant Hanan Ofer. Defendant present and on bond. U.S. Probation Officer Darren Galerkin also present. Defendant sentenced on Count 1 of the Superseding Information to: A term of Probation of two (2) years; Fine in the amount of \$9,500; and Special Assessment of \$100. No forfeiture was ordered and no restitution was imposed. Count 8 of the Indictment dismissed as to Defendant Ofer on Government's motion. Defendant was advised of his right to appeal.
